Interim regulations on doctoral procedures in the MIN Faculty

Enactment of the doctoral degree regulations of the Faculty of Mathematics, Informatics and Natural Sciences of Universität Hamburg from 2nd May 2018: New [doctoral degree regulations of the Faculty of Mathematics, Informatics and Natural Sciences of Universität Hamburg](#) (abbreviated: Doctoral Degree Regulations MIN Faculty (2018)) came into effect from **1 October 2019**. These 'new' doctoral degree regulations replaced the [doctoral degree regulations of the Faculty of Mathematics, Informatics and Natural Sciences of Universität Hamburg](#) from 1st December 2010 (with amendments from 2nd May 2012 and 10th October 2012; abbreviated: Doctoral Degree Regulations MIN Faculty (2010)). In the meantime, both doctoral regulations (Doctoral Degree Regulations MIN Faculty (2010) and Doctoral Degree Regulations MIN Faculty (2018)) have been amended (see amendments at [this link](#)).

All doctoral candidates applying for admission to doctoral procedures in the MIN Faculty as from 1st October 2019 will carry out their doctoral studies according to the Doctoral Degree Regulations MIN Faculty (2018), as amended (see amendments under the above-mentioned link).

The following interim regulations apply for doctoral candidates (see Section 21 of the [Doctoral Degree Regulations MIN Faculty \(2018\)](#)):

Doctoral candidates admitted to doctoral procedures before the enactment of the 'new' doctoral degree regulations can continue their doctoral procedures according to the rules of the Doctoral Degree Regulations MIN Faculty (2018) as amended (see amendments under the above-mentioned link) upon joint request by the doctoral candidate and her/his supervisors. This applies for all doctoral procedures which are conducted according to the Doctoral Degree Regulations MIN Faculty (2010) as amended or the departmental doctoral degree regulations. The application form (see next page) must be submitted to your Academic Office / Doctoral Office.
